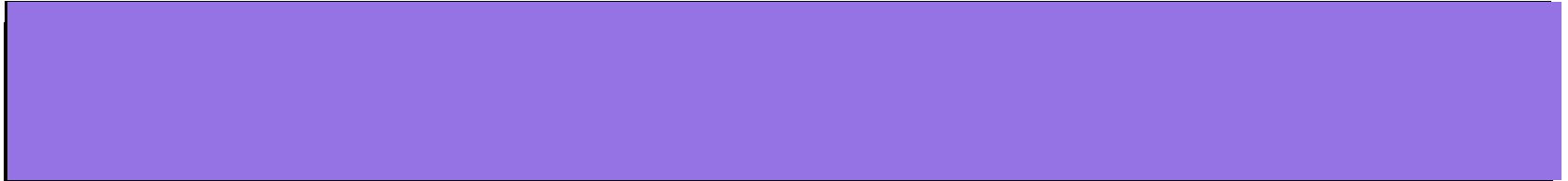
Event Host Sponsor examples:

MEMORANDUM OF UNDERSTANDING

Sponsor Year 2024/2025

Below is an outline of the rights and responsibilities for a Sponsor of the ASID Colorado Chapter

Please review and sign.

This is an understanding between the Colorado Chapter of ASID (the "Chapter") and Sponsor (the "Sponsor").

The Chapter and Sponsor are this day entering this understanding and, for their mutual convenience.

- Chapter will provide a volunteer event lead/liaison to assist in event coordination and set-up between ASID Colorado Chapter and Sponsor.
- Chapter will market the event to membership and contacts by email and via social media outlets.
- Chapter will set up an online registration system, collect registrations and payments. All events will satisfy the standard registration event costs and all attendee registrations must go thru the Chapter registration system.
- Chapter will notify Sponsor of final count of attendees 72 hours before the event.
- Chapter will provide onsite check in and registration.
- Sponsor must be a member in good standing throughout the sponsorship year. Industry Partner membership is an additional cost paid directly to ASID National, separate from ASID CO sponsorship.
- Sponsor will provide food, beverage, and any additional costs regarding but not limited to event supplies, speakers, rentals, etc. for their scheduled event.
- Sponsor may collect business cards at the event; however, attendee and contact information will not be provided by Chapter.
- Sponsor shall indemnify and hold Chapter, its officers, directors, agents and assigns, harmless from and against any and all liability, claims, costs, losses and damages, including reasonable attorneys' fees, caused by the negligent act or omission of Vendor, it's officers, directors, employees, contractors or agents in connection with the Chapter Event Host's Event, including without limitation the death or injury to any person or loss or damage to any property of any persons resulting from the service of alcohol or use of the facility/services.
- In the event alcoholic beverages are served by Sponsor as a part of Sponsor's contract, the Sponsor will provide a minimum of \$1,000,000 liability coverage and shall provide evidence of such insurance to Chapter upon request. Or the Catering Company contracted by the Sponsor to dispense food and beverage, alcoholic and, non-alcoholic. Catering Company is required to provide evidence of liability insurance.
- If either party brings an action to enforce the terms of this Contract or declare rights there under, the prevailing party in any such action, on trial or appeal, shall be entitled to reasonable attorneys' fees to be paid by the losing party.
- In Sponsor's performance under this Contract, Sponsor acts and will act as an independent contractor, and not as an agent or employee of Chapter.
- This Contract shall be construed, interpreted, and applied in accordance with, and shall be governed by, the laws applicable in the state of Colorado, without regard to such state's conflict of laws principles. All parties to this Contract agree to submit to the arbitration under the jurisdiction of the City and County of Denver, Colorado to resolve any dispute arising from, though or in any manner related to this contract.
- Entire Agreement. This Contract constitutes the entire agreement between the parties and may not be waived or modified except by written agreement between the parties.
- Sponsor agrees that this Contract is solely between Sponsor and the Colorado Chapter of the ASID and in no event shall the American Society of Interior Designers, Inc. be liable for any actions of the Colorado Chapter of the ASID or the Sponsor's.
- If acts of God or government authorities, natural disasters, severe weather, or other emergencies make it illegal or impossible for the parties to perform their obligations under the Contract, the Contract will be terminated and both parties will make best efforts to reschedule.
- Chapter may cancel this Contract at any time upon written or electronic notice to Sponsor. The failure of Sponsor to perform any service under this Contract or a failure to perform any provision under this Contract will be considered a Breach of Contract and Chapter shall be able to terminate this Contract and seek any damages.

IN WITNESS WHEREOF, the parties have caused this Memo of Understanding to be duly executed, intending thereby to be legally bound.
